In consideration for the Participant’s participation in the Regatta, the undersigned, on behalf of the Participant, and on behalf of Participant’s respective heirs, executors, administrators, parents, personal representatives and next of kin (collectively with Participant, “Releasers”), hereby forever waives, releases and discharges the Chicago Yacht Club, its affiliates, and their respective members, managers, employees, agents, volunteers, sponsors, officers, directors, representatives, successors and assigns (each a “Released Party”) from any and all claims, demands, damages, judgments, executions, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, which one or more Releasers may have, or claim to have, against any Released Party resulting from death, personal injury, property damage or other loss any Releasers may sustain as a result of participant’s participation in any sailing activity associated with the Regatta, other related activities (including land-based activities, such as parties related to the Regatta), or the use of the Chicago Yacht Club’s facilities. **Use of Email:** I understand that the Club sends emails to participants in the Race. I have no objection to the Club sending the Participant such emails and I consent to the same. **Publication of Name & Home City:** I understand that the Club may publish the names and home cities of those participating in the Race. I have no objection to the Club publishing the Participant's name and home city and I consent to the same.

**THIS RELEASE IS INTENDED TO DISCHARGE EACH RELEASED PARTY FROM ANY AND ALL LIABILITY ARISING OUT OF OR CONNECTED IN ANY WAY WITH PARTICIPATION IN THE REGATTA, EVEN IF THAT LIABILITY ARISES OUT OF NEGLIGENCE OR CARELESSNESS ON THE PART OF ANY RELEASED PARTY.**

Releasers hereby acknowledge that serious accidents occasionally occur during sailing activities and that mortal or serious personal injuries and/or property damage or other loss may result from participation in sailing activities, including further injury or damage sustained as the result of the efforts of third parties who come to the aid of Participant. **Releasers hereby voluntarily assume these and all other risks inherent to the sport of sailing, including the risk of injury or death.** Releasers hereby agree to indemnify and hold harmless the Released Parties for claims, demands, damages, judgments, executions, rights of action or causes of action by any third party arising from or relating to the action or inaction of any one or more Releasers.

I grant the Chicago Yacht Club, its agents and assigns the unconditional and perpetual right to publish and broadcast anywhere in the world for any purpose and in any media the names and images of Participant relating to or arising from his or her participation in the Regatta or any other related activities.
